Stéphane takes an unconventional route to becoming a European Patent Attorney

Stéphane Ambrosini, a UK patent and trade mark attorney at Franks & Co in Sheffield has finally received the news that he's been waiting 12 years to hear. After 10 years of training, studying and numerous professional qualifications gained, he has finally qualified as a European Patent Attorney (EPA).

Stéphane's route to qualification is unconventional to say the least. Most European Patent Attorneys qualify within 2 to 6 years, having obtained a technical qualification at degree level. However, Stéphane gained a French technical qualification (Brevet de Technicien Supérieur) and completed 10 years of training necessary to enable him to sit the exams to become an EPA. In addition, he sat his exams in English despite the fact that Stéphane's first language is French.

Most of Stéphane's formal qualifications preceding his entry into the IP profession were international business-oriented, including a Business Studies degree at Sheffield Hallam University. Stéphane says "To provide the best advice for our clients' intellectual property requirements, it is important to take the time to fully appreciate the nature of their business from a commercial as well as a legal perspective."

Now that Stéphane is a Professional Representative at the European Patent Office (EPO) he is able to represent clients from all over the world regarding all matters relating to European patents. Stéphane explains why this qualification is so important "At Franks & Co, the philosophy of the firm is that each attorney manages their client's entire intellectual property (IP) portfolios. This approach allows us to manage our clients' requirements more efficiently and effectively, as they only have to deal with one point of contact and the attorney can provide a genuine focus to the business."

Stéphane is in good company at Franks & Co, as the majority of the attorneys at the firm are European Patent Attorneys.
