• Drafting patent specification up to international patent cooperation treaty (PCT) standard: £4,000 plus VAT

United Kingdom Intellectual Property Office (UKIPO)

- Filing our professional fee: £425 plus VAT.
- Prosecution to grant at UKIPO our professional fee: £6,500 plus VAT; and
- Official fees (variable on length of document) £310 no VAT (for an application with 35 or fewer pages to the description and 25 or fewer claims).

European Patent Office (EPO)

- Filing our professional fee: £1,200 plus VAT.
- Prosecution to grant at EPO our professional fee: £15,000 plus VAT; and
- Official fees (variable on length of document) €4,255 no VAT (for an application with 35 or fewer pages and 15 or fewer claims).

International Patent Application - Patent Cooperation Treaty

- Filing our professional fee: £1,600 plus VAT.
- Prosecution to 30-month stage our professional fee: £4,000 plus VAT; and
- Official fees (variable on length of document) €3,412 no VAT (for an application with 30 or fewer pages).

*fixed fees apply to our professional fees only. Prosecution cost is spread out over the duration of the patent pending procedure. Guideline costs for official fees are given. Official fees vary depending on the length of document and number of claims and any optional searches or examinations.
